The rules and regulations of this contract apply to each student who participates in extra-curricular activities as a member of an activity, club, performing group, or an elected office of the student body.

Students participating in extra-curricular activities must abide by all rules and regulations that are set forth by Wenatchee School District. Students in violation of any of the rules and regulations shall be subjected to the disciplinary action chart. Students disciplined, suspended, or expelled from any activity by these rules and regulations shall be entitled to the appeal procedure as outlined in the discipline section of the school district policy handbook.

A. RULES AND REGULATIONS THAT APPLY TO PARTICIPANTS IN ALL ACTIVITIES

1. Be enrolled in regular attendance in school
2. Be in attendance all day of the activity unless excused prior to absence by the attendance office and permission by the administration has been given to participate.
3. Be in good standing with the school and with the particular area of participation.
 - a. Not be suspended from school or on any other form of disciplinary action that would prevent participation.
 - b. Have fulfilled all requirements for the specific activity area.
4. A participant shall refrain from using obscene or vulgar language.
5. A participant shall not steal, or use another's property without permission of the owner.
6. A participant shall not engage in conduct detrimental to the group or school.
7. A participant is expected to attend all scheduled practices, meetings, contests, and performances.
8. A participant in any activity is required to be neat, clean, and well groomed.
9. School owned equipment checked out by a participant in any activity is his/her responsibility. The loss or misuse of this equipment will be the financial obligation of the participant. Participants will not be allowed to continue competition or receive awards until this obligation is fulfilled.
10. A student is expected to travel to and from contest or performance with the group when transportation is provided for this purpose. Any exception must be cleared by the administration, coach, advisor or director.
11. In addition to this activities contract, participants may be required to adhere to the rules which are unique to a particular sport or activity.

B. SPECIFIC REQUIREMENTS FOR ACTIVITIES OTHER THAN ATHLETICS

1. Purchase an ASB card if appropriate. (Activity involved uses ASB funds.)
2. Show proof of *medical insurance* or purchase a school *medical insurance* package if insurance is required for activity.
3. Provide current and proper emergency information (emergency card) if the activity involves traveling out of town.
4. During the school year the use, possession, trafficking, or enticement of alcohol, controlled substances or tobacco is a violation of the school district policy.
5. Abide by all rules and regulations that are set forth by the activity, club group, advisor or administration.

STATEMENT OF AGREEMENT AND UNDERSTANDING

I have read and understand the above rules and regulations and the disciplinary action chart outlined in the activities contract and within the disciplinary action chart and agree to follow all standards set forth in this contract. I further understand that the time period for which this contract is in effect is, for year-long activities (i.e., ASB officers, drill teams, FBLA) from the first official day of fall sports practices through the last day of school or the culminating awards ceremony or, for seasonal activities (i.e., drama productions) from the first official day of practice through the culminating awards ceremony.
